Such turnaround from profit to loss attributable to Shareholders was mainly attributable to (i) the reduction in revenue generated from both healthcare services business and money lending business during the Review Period; (ii) an increase in administrative and other expenses primarily due to increase in staff cost; and (iii) appreciation in RMB for the Review Period resulting in unfavorable RMB exchange rate million primarily.
