Diwangchi is located in Maotai Town, Renhuai City, Guizhou Province, the PRC, a famous liquor-producing area, also known as Canglongtan, which is one of the sources of the Chishui River in China. The "Diwangchi" liquor is brewed with local glutinous sorghum using the water of Diwangchi. The "Diwangchi" liquor won a silver medal at the 2022 International Spirits Grand Challenge (ISGC) China.

As at the date of this announcement, the Group is principally engaged in healthcare products and services and money lending business. The Board considers that the entering into of the Agreement by King International will be beneficial to the Group in developing new business growth areas. The New Business Activity represents a good opportunity for the Group to diversify its business and income streams, which will ultimately enhance the financial performance and profitability of the Group.
