Upon the full placement of the 22,910,489 Placing Shares, the gross proceeds raised from the Placing will be approximately HK\$12.37 million. After taking into account the estimated expenses in relation to the Placing, the estimated net proceeds from the Placing will be

approximately HK\$11.7 million, representing a net price of HK\$0.51 per Placing Share. The net proceeds from the Placing are intended to be used for general working capital of the Group. The Group will direct the net proceeds together with other resources of the Group amounting to HK\$40 million in aggregate for conducting the Group's short term treasury activities to generate short term revenue (including short term securities investments and money lending activities), pending the actual application to the Group's general working capital as required.
