On 18 April 2013, after trading hours, the Company entered into the Placing Agreement with the Placing Agent pursuant to which the Placing Agent has conditionally agreed with the Company to place 22,910,489 Placing Shares on a fully underwritten basis to the Placees who are Independent Third Parties at the Placing Price of HK\$0.54 per Placing Share.

The Placing Shares will be allotted and issued under the General Mandate granted to the Directors at the extraordinary general meeting of the Company held on 25 March 2013. As at the date of this Announcement, no Shares have been allotted and issued pursuant to the General Mandate. The 22,910,489 Placing Shares to be allotted and issued will fully utilize the General Mandate, representing approximately 20% of the existing issued share capital of the Company as at the date of this Announcement, and approximately 16.67% of the enlarged issued share capital of the Company immediately following the Placing. Since the Placing Shares will be allotted and issued under the General Mandate, no further Shareholders' approval is required.

The Completion of the Placing is conditional upon the Listing Committee of the Stock Exchange granting approval for the listing of and permission to deal in the Placing Shares.

If the foregoing condition is not fulfilled on or prior to the 30th day after the date of the Placing Agreement (or such later date as may be agreed between the Company and the Placing Agent), the Placing Agreement shall terminate and none of the parties to the Placing Agreement shall have any claim against the other for any costs or losses (save for any prior breach of the Placing Agreement).

The gross proceeds and net proceeds from the Placing will be approximately HK\$12.37 million and HK\$11.7 million, respectively, which will be used for general working capital of the Group.

Shareholders and potential investors should note that Completion of the Placing is subject to fulfillment of the condition under the Placing Agreement. As the Placing may or may not proceed, Shareholders and potential investors are reminded to exercise caution when dealing in the Shares.

THE PLACING AGREEMENT

Parties

Issuer: The Company

The Placing Agent: Freeman Securities Limited. To the best of the Directors' knowledge, information and belief and having made all reasonable enquiries, the Placing Agent and its associates are Independent Third Parties.

The Placing

Pursuant to the Placing Agreement, the Placing Agent has conditionally agreed, during the period from the execution of the Placing Agreement to 5:00 p.m. on the 15th day after the date of the Placing Agreement (or such other period as agreed by the Placing Agent and the Company), to procure the Placees to subscribe 22,910,489 Placing Shares at HK\$0.54 per Placing Share, representing approximately 20% of the issued share capital as at the date of this Announcement, and approximately 16.67% of the issued share capital as enlarged by the issue of the Placing Shares. The Placing is fully underwritten. The aggregate nominal value of the Placing Shares will be HK\$2,291,048.90.

The Placees

The Placing Shares will be placed to not less than six Placees which will be individuals, institutional or other professional investors, and who and whose ultimate beneficial owners shall be Independent Third Parties. The Placing Agent has agreed to use all reasonable endeavours to ensure that none of the Placees and their ultimate beneficial owners shall become a substantial shareholder (as defined under the Listing Rules) of the Company upon taking up the Placing Shares.

Placing Price

The Placing Price of HK\$0.54 per Placing Share represents:

- (i) a discount of approximately 15.63% to the closing price of HK\$0.64 per Share as quoted on the Stock Exchange on the Last Trading Day; and
- (ii) a discount of approximately 15.63% to the average closing price of HK\$0.64 per Share as quoted on the Stock Exchange for the last five trading days up to and including the day immediately prior to the Last Trading Day.

The Placing Price of HK\$0.54 per Placing Share was determined on arm's length basis between the Company and the Placing Agent based on current market conditions and the prevailing market price of the Shares. The Directors (including the independent non-executive Directors) consider that the Placing Price of the Placing Shares is fair and reasonable and is in the interests of the Company and the Shareholders as a whole.

Ranking of the Placing Shares

The Placing Shares will be issued fully paid up and ranking *pari passu* in all respects among themselves and with the existing Shares in issue, including to the right to receive all dividends and distributions which may be declared made or paid after the Completion Date and will be issued free and clear of all liens, encumbrances or other third party rights.

Condition of the Placing

The Completion of Placing is conditional upon the Listing Committee of the Stock Exchange granting approval for the listing of and permission to deal in the Placing Shares.

If the foregoing condition is not fulfilled on or prior to the 30th day after the date of the Placing Agreement (or such later date as may be agreed between the Company and the Placing Agent), the Placing Agreement shall terminate and none of the parties to the Placing Agreement shall have any claim against the other for any costs or losses (save for any prior breach of the Placing Agreement).

General Mandate

22,910,489 Placing Shares will be allotted and issued under the General Mandate. Under the General Mandate, the Directors are allowed to allot and issue up to 22,910,489 Shares. As at the date of this Announcement, no Share has been allotted and issued pursuant to the General Mandate. Accordingly, the issue of the Placing Shares is not subject to any further approval by the Shareholders. The 22,910,489 Placing Shares to be allotted and issued will fully utilize the General Mandate.

Completion of the Placing

Completion of the Placing will take place on the second Business Day after the date on which the condition in respect of the Placing under the Placing Agreement is fulfilled or such other date as the Company and the Placing Agent may agree.

Commission

The Placing Agent will be entitled to a commission of 3% of the amount equivalent to the Placing Price multiplied by the total number of the Placing Shares.

Termination

The Placing Agreement may be terminated if at any time prior to 3:00 p.m. on the Completion Date, in the reasonable opinion of the Placing Agent that the success of the Placing or the business or financial prospects of the Group would or might be adversely affected by:

- (i) any material breach of any of the representations and warranties contained in the Placing Agreement; or
- (ii) any of the following events:
 - (a) the introduction of any new law or regulation or any change in existing laws or regulations or change in the interpretation or application thereof whether in Hong Kong, Cayman Islands or elsewhere; or
 - (b) the occurrence of any event, development or change (whether or not local, national or international or forming part of a series of events or changes occurring or continuing before, on and/or after the date hereof and including an event or change in relation to or a development of an existing state of affairs) of a political, military, industrial, financial, economic or other nature, whether or not sui generis with any of the foregoing, resulting in a material adverse change in, or which might be expected to result in a material adverse change in, political, economic or stock market conditions; or
 - (c) the imposition of any moratorium, suspension or material restriction on trading in securities generally on the Stock Exchange occurring due to exceptional financial circumstances or otherwise; or
 - (d) a change or development involving a prospective change in taxation in Hong Kong or Cayman Islands or elsewhere or the implementation of exchange controls which shall or might materially and adversely affect the Group (as a whole) or its present or prospective Shareholders in their capacity as such; or
 - (e) any change or deterioration in the conditions of local, national or international securities markets occurs,

then and in any such case, the Placing Agent may terminate the Placing Agreement without liability to the Company by giving notice in writing to the Company, provided that such notice is received prior to 3:00 p.m. on the Completion Date.

In the event that the Placing Agent terminates the Placing Agreement by giving notice to the Company as afore-mentioned, all obligations of each of the parties under the Placing Agreement shall cease and determine and no party shall have any claim against any other party in respect of any matter arising out of or in connection with the Placing Agreement except for any breach arising prior to such termination.

Application will be made by the Company to the Listing Committee of the Stock Exchange for the listing of and permission to deal in the Placing Shares.

Notes:

1. Radford Developments Limited is a company incorporated in the British Virgin Islands with limited liability and is wholly-owned by Moon Light Investments Group Limited, which in turn is wholly-owned by Moon Light Trust. Fidelitycorp Limited is the trustee for Moon Light Trust.
2. Assuming no other issue of new Shares and no repurchase of existing Shares before completion of the Placing, and Placing Agent has placed a total of 22,910,489 Placing Shares to not less than six independent Placees. It is expected that none of the Placees will become substantial Shareholder(s) of the Company (as defined under the Listing Rules) upon completion of the Placing.

REASONS FOR THE PLACING AND USE OF PROCEEDS

The Company is principally engaged in (i) apparel retail business in the PRC and (ii) luxury goods and accessories retail business (watches, audio equipment and products, and other accessories) and the sale of crystal gemming services and products in Hong Kong and the PRC.

Upon the full placement of the 22,910,489 Placing Shares, the gross proceeds raised from the Placing will be approximately HK\$12.37 million. After taking into account the estimated expenses in relation to the Placing, the estimated net proceeds from the Placing will be

approximately HK\$11.7 million, representing a net price of HK\$0.51 per Placing Share. The net proceeds from the Placing are intended to be used for general working capital of the Group. The Group will direct the net proceeds together with other resources of the Group amounting to HK\$40 million in aggregate for conducting the Group's short term treasury activities to generate short term revenue (including short term securities investments and money lending activities), pending the actual application to the Group's general working capital as required.

In view of volatile market conditions and uncertain global economy, the Directors consider that it is a good timing and opportunity to conduct the Placing in order to raise additional funds so as to broaden the Company's capital and shareholder base. Accordingly, the Directors consider that the Placing is in the interest of the Company and the Shareholders as a whole.
