Such decrease was primarily attributable to, among other things, the increase in staff costs, the losses on disposal of debts instruments at fair value through other comprehensive income, the increase in impairment losses of debts instruments at fair value through other comprehensive income which is partly offsetted by the increase in share of profit from joint venture of the property development sector.

As the Company is still in the course of preparing its interim results for the six months ended 30 September 2021, the information contained in this announcement is solely based on the preliminary assessment of the Board after reviewing the draft unaudited consolidated management accounts of the Group for the six months ended 30 September 2021 which have yet to be finalised.
