Note (A) : On 6 April 2011, the Issuer (as purchaser) entered into an acquisition agreement with Mr. Wang Zhong Sheng (as vendor) ("the Acquisition Agreement") pursuant to which the Issuer conditionally agreed to acquire and the Vendor conditionally agreed to sell the 100% issued share capital of Wealthy Talent Global Investments Limited for a consideration of RMB420,000,000. The consideration shall be satisfied upon completion of the acquisition by the Issuer by the issue of the convertible bonds to the Vendor or its nominee(s) which shall be a company controlled by him. Based on the conversion price of HK\$0.26 per conversion share (subject to adjustments) and assuming full conversion, 1,919,230,769 conversion shares will be allotted and issued. Pursuant to the Listing Rules, the Acquisition Agreement constituted a major and connected transaction of the Issuer and was approved by the independent shareholders of the Issuer at the extraordinary general meeting held on 20 June 2011.

For details of the Acquisition Agreement, please refer to the announcement of the Issuer dated 6 April 2011 and the circular of the Issuer dated 30 May 2011. The acquisition contemplated under the Acquisition Agreement has been completed on 12 July 2011. As at 31 March 2013, 860,000,000 conversion shares were allotted and issued by the Issuer.

(B) : On 14 March 2013, the Company and Vision Finance International Company Limited (the "Placing Agent") has entered into a placing agreement, whereby the Company has conditionally agreed to place, through the Placing Agent, on a best efforts basis, a maximum of 400,000,000 new ordinary shares of the Company (the "Placing Shares") to independent investors at a price of HK\$0.25 per Placing Share (the "Placing"). The Placing was conditional upon, among other things, the Listing Division of The Stock Exchange of Hong Kong Limited granting or agreeing to grant the listing of, and permission to deal in, the Placing Shares. As at 31 March 2013, the Placing was not completed yet.
